**1. Welcome & Introductions**

**2. Approval of September 2025 Meeting Minutes**

**3. Oversight Updates**

The Education One team presented updates on current application and renewal statutes for schools during the 2025-26 school year. The board voted on three renewal recommendations:

Jason motioned to approve. Kayla seconded the motion. The motion carried unanimously, 3-0.
